

## Sex Offender Agreement

Pleasant Valley Baptist Church wants to serve all people and provide them with opportunities to worship. For the benefit and protection of all people the Church requires those persons who are required under any State or Federal Statute, Rule, or Regulation or any Court Order to register as a sex offender with any court, any government entity, agency, department and/or any law enforcement agency and/or department to enter into this Agreement. For the purposes of this Agreement, said persons are hereinafter referred to as "offenders." Because the church must also consider the concerns of others who participate in services and church activities, the Church requires sex offenders to agree to certain terms in order to attend worship services and receive consideration for other ministry opportunities.

Offenders are required to enter into this Agreement before attending any worship services and/or receiving or participating in any other ministry opportunities or Church activities of any kind. The terms are established at an initial meeting between the individual offender and representatives of the church. Church representatives will include at least one Courtesy Team member, the Church's administrator and a pastor. The offender's parole or probation officer may be invited to attend as well.

The terms will be reviewed by Church representatives and the offender at approximately six-month intervals to determine if changes should be made. The parole or probationary officer may be invited to participate in the review process.

Following are the terms. All that will apply must be initialed by the individual and by a representative of the Church.

- \_\_\_\_\_    \_\_\_\_\_    Understand that Church representatives may contact my parole or probation officer to whom I report as often as they deem necessary.
- \_\_\_\_\_    \_\_\_\_\_    I am required to have one or more accountability partners who will host me at all times while on church property.
- \_\_\_\_\_    \_\_\_\_\_    I understand that all accountability partners must be approved by the Church and may be invited to a meeting or meetings to review my specific situation and requirements.

- \_\_\_\_\_ I am required to be driven onto church property by an accountability partner.
- \_\_\_\_\_ I must be accompanied by an accountability partner or Courtesy Team member when going to the restroom.
- \_\_\_\_\_ I am permitted to attend the (6pm Sat. or 9:15am Sun. or 10:45am Sun.— must choose one) \_\_\_\_\_ worship service.
- \_\_\_\_\_ I must check in with a Courtesy Team member in the Connection Center immediately upon entering the building.
- \_\_\_\_\_ I must check out with a Courtesy Team member in the Connection Center when ready to leave the building.
- \_\_\_\_\_ I am required to sit in an aisle seat in the worship center. If one is not available, I will seek assistance of a Courtesy Team member.
- \_\_\_\_\_ I am required to not sit by a minor, which is defined as anyone 16 years of age or younger.
- \_\_\_\_\_ I will make every effort to not come into contact with minors.
- \_\_\_\_\_ I will not attend a small group.
- \_\_\_\_\_ I may attend a small group that has been approved by the Church’s representatives with the understanding that the group leader will be informed of my background. I further understand that the group leader will be told that I cannot attend social or other activities of the group. In other words, I may attend regular Bible study time only.
- \_\_\_\_\_ I will not attend any church activities other than those noted above whether on or off campus including Support Groups, Sporting events, Church sponsored events or Celebrate Recovery and special events such as the Singing Christmas Tree performances or concerts.
- \_\_\_\_\_ I will not attempt to serve in any church ministries.
- \_\_\_\_\_ I may receive one-on-one discipleship with the understanding that the discipleship teacher will be informed of my background and will be asked to meet me off campus at a restaurant or other public location.
- \_\_\_\_\_ I may contact \_\_\_\_\_, the assigned Church representative, if I have questions or concerns.

\_\_\_\_\_ I understand and agree to the following steps and consequences if I am suspected of violating this agreement:

The offender is expected to explicitly adhere to this agreement. If a violation is suspected, the offender will meet with Church representatives at a time and place and in a manner determined by the Church in its sole discretion to review the suspected violation and the Church's concerns. The offender's parole or probation officer may be invited to participate in the meeting. If the violation is confirmed by the Church representatives in their sole discretion, the offender will no longer be permitted to attend church or permitted on church premises at any time. Presence on church property from that point on will be considered trespass and authorities will be called to report the trespass.

I \_\_\_\_\_ have read and understand the preceding agreement and have initialed the specific requirements that provide me with opportunities to attend Pleasant Valley Baptist Church. By initialing these statements, I am agreeing that I will adhere to these terms and that they are in effect until they are replaced by another signed agreement offered to me by the Church. I understand that if I do not adhere to the terms of this agreement, I will no longer be permitted to attend the Church. I consent to and will execute any and all documents necessary to allow the church to obtain any of the information or make any of the contacts described herein or as may be reasonably requested by the Church, and I further state such requests will not invade any confidentially and/or privacy rights I may have and I expressly waive any privacy rights or confidentiality. Additionally, I expressly authorize the Church to reasonably disseminate any and all information it learns directly and/or indirectly from me and/or from documents I have authorized the Church to obtain and/or review to give effect to this Agreement. Notwithstanding any of the above, I further acknowledge that the Church may terminate, limit, or modify in any manner at its sole discretion at any time with or without reason or explanation my ability to attend Church and/or participate in Church activities as set forth above.
